In order to encourage students to explore subject matter outside their program of study and to promote interdisciplinarity, all upper-year Bachelor of Health Sciences students will be permitted to designate 6.0 units of degree-credit courses for pass/fail grading, thereby minimizing any risk to the students' GPA.

The Personal Interest Credit policy applies to all students who:
are registered in a plan that will lead to the completion of a Bachelor of Health Sciences degree;
have successfully completed a minimum of 24.0 units at Queen's; and
are in good academic standing (GPA of 1.60 and higher).

A student may choose to designate a non-Health Sciences elective that would normally have letter grading for pass/fail grading, designating the course as a Personal Interest Credit (PIC), subject to the policies of the Faculty or School offering the course.

No course which can be used as a Core, Option, or Supporting course in the student's degree plan is eligible to be a Personal Interest Credit. If you are unsure if this course is a requirement, please run an Academic Requirements Report in SOLUS or refer to the BHSc curriculum outlined on the website.

Please note, you must currently be enrolled in the course to select the course for a Personal Interest Credit.
